Representative Small,

Thank you for your timely response. I appreciate that your time is valuable and I hope that our conversation is not a waste of time for either of us.

You wrote:

>Recently, reports were published that President Trump withheld military aid to pressure the Ukrainian President into interfering with our national election. If true, President Trump's efforts to leverage the power of his office for personal political gain is evidence he put America's national security at risk.

And if false, these reports represent an effort to deceive not only yourself and all other Democrats in Congress, it is an effort to deceive the American people as well. Let's see, is there anyone in Congress who stands to lose a great deal of money and possibly go to jail if the truth about Joe Biden and Ukraine comes out to all Americans?
